We decided to schedule a fall Dash for the Dog Park 5K on October 23<sup>rd</sup> at 9 a.m. We can use the same T-shirts and will consider the possibility of doing a costume contest.

**Restore Sign:** The sign will be 24"X24" and will cost \$60 + tax.

**ACTION:** Jill H. moved that we approve the cost of the sign. Ann F. seconded. Motion carried.

**Design Committee:** Derek Brinkerhoff from Garrett spoke and emphasized that the changes we are hoping to make take time and not to get discouraged. The RDC can both purchase and sell properties. The town is still discussing adding a Code Enforcement Officer to the town budget. RDC is in the process of expanding the Tiff district. The EDA plan has to include plans to purchase specific properties in order for the RDC to have the authority to purchase them as they become available.

## **NEW BUSINESS**

**OCRA Meeting**: OCRA encouraged us to ask the leadership of the various towns in Noble County to provide financial support for the Dog Park since it will be the first one in Noble County. Todd C. will craft a letter to send to each municipality.

Website Hosting & Domain: We need to renew our Web contract. This costs approximately \$380.
